### From the Executive Director

# Good Works is celebrating its 35th anniversary in 2023!

#### THIRTY FIVE YEARS OF REPAIRING HOMES AND

RESTORING HOPE. Where does the time go? I have been a Good Works volunteer for 32 of those years and served as its Executive Director for the past 9 years. I have worked with a multitude of amazing staff and volunteers and together we have brought hope, joy and dignity to over 1,100 low-income families in Chester County. We have weathered many storms and celebrated many milestones and I, like you, have marveled at how God has provided everything we have needed to fulfill our mission since 1988.



This past year was both wonderful and challenging, as you will come to appreciate reading this annual report. Volunteerism increased as pandemic fears continued to wane. 162 families were recipients of our services and 39 homes were fully completed. Good Works Ambassadors reported a record number of faith touches and our Ambassador program expanded beyond Chester County into Georgia and Alabama. 18 individuals recognized their need for a savior and indicated a decision to follow Jesus. All of that was wonderful. The greatest challenge this past year was the result of an unstable economy, where markets were depressed and inflation at record levels. Charitable giving across all sectors was down 7-10% while the average cost to complete a home rose 27%. The Finance Committee and the Board of Directors recognize that economies are cyclical and we chose to tap reserves to cover the fund raising shortfall this year.

As we embark on the next fiscal year, our financial budget and operational plans reflect the financial realities of these times with confidence that God will provide exceedingly all that we need as promised in Philippians 4:19.

I look forward with great anticipation to what He will do through our staff, volunteers, partners, donors and friends. That is the relevance of the rainbow on the cover of this year's report. None of us knows what the future will bring, but the rainbow reminds us of God's everlasting covenant and His "promise in the clouds" that He is always with us. He is where our hope comes from and is the source of hope that we share with every volunteer, donor and family we assist.

■ WATCH LACEY'S VIDEO IT WAS A BIG DAY WHEN LACEY MOVED INTO HER FIRST HOME. It was a mobile built in 1967, but seemed in pretty good shape and was conveniently located two units down from her grandmother. Lacey was 17 years of age at the time and pregnant with her first child. Little did she know then, that life was about to throw her some wicked curve balls. Fast forward to 2021. Lacey is 24 and now raising two children alone. Both fathers are incarcerated. She is working hard at a medical equipment company, but her full-time employment earns just enough to make ends meet. That is until her mobile home began showing its true age.

The heater was the first thing to go. Then the pipes froze. She soon learned that the mobile had never been properly insulated. Then the roof began to leak. She would pay repairmen, but the jobs were never done right and her problems only worsened. As the roof began to collapse, the windows seized and shattered. Holes in her floor provided welcome access to bugs and mice. Through it all, Lacey did her best to keep the place clean and tidy, in spite of the water-logged wall and ceiling panels that would fall onto her furniture and floors after every rain. "I had nowhere else to go," Lacey lamented, that is, until her grandmother, Rose, suggested she call Good Works. Rose had been assisted by Good Works many years earlier but Lacey didn't think she would qualify. In her application for assistance she wrote: "I don't get any food stamps or government assistance because I'm working full-time, but I can't afford to fix my house. I just want to get my house repaired so my children can be safe and happy and proud of where they live."

Upon inspection, the home was actually in worse condition than Lacey knew. The Great Valley Presbyterian Church team under the leadership of work crew leader Brian Gilbert was assigned to repair the home, with their efforts punctuated by a week-long summer work camp session and several corporate workdays. "The transformation is incredible," Lacey shared, "Good Works added an additional room so my daughter and son could have their own bedrooms." Everything Lacey requested and much more was accomplished. "I still can't believe that this is my house! My kids get so excited when the volunteers come to work. They love to show off their new rooms. But, I most appreciate meeting all the people who worked on my home. They brought me hope!"







### **Repairing Homes**

MANY PEOPLE THINK OF AFFORDABLE HOUSING AS VOUCHERS, RENTAL ASSISTANCE, TAX CREDITS, AND NEWLY CONSTRUCTED HOMES WITH LOW-INTEREST

LOANS. However, home repairs and modifications are also an important solution to the housing crisis in Chester County. Home preservation is the best and most affordable housing option for the majority of low-income households. According to the Coalition for Home Repair, "building new homes won't solve the problem. For every affordable housing unit that is built, two others are lost to abandonment, deterioration, or conversion to more expensive housing. It also costs about 26 times more to build a new affordable home than to repair an existing one." The Centers for Disease Control and Prevention has identified investing in home repairs for low-income households as a high-impact strategy for addressing root causes of poor health. Home repairs and modifications allow people with disabilities, veterans, and older adults to avoid institutional care and remain safely in their homes.

On today's visit Robin said she had been in the hospital, then rehab and had just recently returned home. So I prayed with her for peace and healing, and encouraged her that Jesus knows her suffering, her condition and that one day very soon He will return and she will be set free from her ailments and receive a perfect body or sooner if He calls her home. We discussed what this will be like. Imagining it is an amazing thing. I encouraged her with Hebrews 12:1-6 that tells us to fix our eyes on Jesus, the author and perfector of our faith. We discussed the signs we are seeing that point to Jesus' imminent return as a way to look past our current hardships and live with this hope. 

When I arrived at Sally and Don's home, the volunteers were busy at work determined to get a lot accomplished before the forecasted rain. I asked Don how his night was. He said he and Sally were able to take their first shower in their home in five years! Thankfully they had a relative a few trailers down the road that would let them wash up regularly. Thank God for family! Don and I did a "happy dance" and shouted giving God the glory, which was the title of today's devotional message. We read Scripture and talked about pride and boasting. He admitted he struggles with boasting and I told him to ask God to help us because we get weak at times and that's when we should humble ourselves and lean and depend on God. To "be strong in the Lord and the power of His might" (Ephesians 6:10) and He will lift us up as the Scripture says. I asked Don to read the devotional and questions and to give me his feelings and ideas. He dove right in and let the Holy Spirit reveal Himself as he read. God showed up and showed out. He told me he suffered from ADHD, anxiety and depression (self-diagnosed) but that it had been better the past two weeks as he had been surrounded by God's Word and God's people - To God Be The Glory! I prayed with him concerning his self-diagnosis that God would guide him and his mind in the way he should go in the future, casting ALL his cares on the Lord. Don thanked and hugged me as I departed.



### **FAITH REPLICATION**

Good Works replication beyond Chester County was realized in 2022 through our Faith Affiliate program and Kick Start initiative. Two non-profit home repair organizations, The Nehemiah Project of Fairburn, GA and Alabama Rural Ministry of Auburn, AL have been adopted by Good Works as Faith Affiliates. Both received a year's worth of Bibles, Christian tracts, monthly Scripture Messages and training for launching their own Ambassador ministry.



We began the day by sharing some community resources with our homeowner that he had requested. Since the team was working in the living room we met with Mike and his 3 children in the kitchen. I spoke with the boys about what they had been learning in school and how they like the new church they are attending. With the way the conversation went, I felt it was a good time to present the gospel to them. I have a large gospel packet someone gave me that you keep turning inside out to explain the gospel to children. When I got done I asked them if any of them would like to ask Iesus to forgive their sins and have them washed away and become as white as snow and believe with all their heart that

Jesus took the punishment that they deserve and rose again. I explained how it is different to just know this and that doesn't make them right with God. I explained that they need to believe it with all their heart that He did it for them. Connor immediately responded that he wanted to and was soo excited! Sam also said that he wanted to. Then Sam's sister said, "Oh Sam's just saying that." I replied that I didn't think so. I could see his face. I reminded Sam that he should not do this unless he believed with all his heart and he said, "Yes I want to." So we prayed and then talked again about what it meant and how they could grow in their new relationship with Jesus Christ. The boys were so excited!

This year, Great Valley is set to begin work on their 35th home, just in time for Good Works 35th anniversary. But there were no losers in this competition. Two homeowners received new roofs at no cost and the E&E teams experienced a great day of service and fellowship. "This is a shout out to my guys," Matt shared, "We believe that the people around us matter. It is crucial for us to give back to the community that keeps us in business." ON THE HEELS OF THE COVID PANDEMIC, 2022 HELD A LOT OF PROMISE. That is, until a broad-based and sharper than expected slowdown slammed the global economy. Soaring inflation, Russia's invasion of Ukraine and the collapse of cryptocurrency drove equity markets to their lowest year-end close in decades and the cost of living to record highs. It came as no surprise then, that charitable giving to Good Works was down 7-10% across all sectors. Adding to theses financial pressures, was the fact that the average cost to complete a home rose 27%. Recognizing the situation, the Finance Committee and the Board of Directors chose to tap reserve funds to cover the fund raising shortfall enabling Good Works staff and volunteers to continue to assist families through the conclusion of the fiscal year.




